The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and
  other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to transfer nutrients and organic carbon that support downstream foodwebs?
- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

Note: the above list of considerations is not inclusive and other functions observed or known to occur should be documented below:

B. ADDITIONAL COMMENTS TO SUPPORT JD: As detailed in Section III(F), above, we propose that Pond 1 and Wetland 5, potentially jurisdictional waters, on the project site are non-jurisdictional waters based on SWANCC. The District determination is that these waters are geographically isolated without a connection to interstate commerce. These features are respectively, approximately 2,540 and 2,595 feet from the nearest jurisdictional water of the United States. There is no natural or man-made discrete and/or confined surface water

connection between these features and any other jurisdictional water. There is no evidence of surface-water flow to or from either feature, nor are they located in the mapped 100-year flood plain. Therefore, during times of heavy precipitation there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into these features. Contrary to the indication that an established drainage feature is present down-slope of these features, as depicted the USGS Quadrangle Sheet, field verification has demonstrated that these features are not located immediately upslope of other jurisdictional waters, and based on their landscape position, they do not appear to be part of a recognizable hydrologic system. Further, they would not be considered a traditional navigable water since they do not have the necessary water depth to support navigation of any kind. Neither feature crosses any state boundary, and do not have a use which would associate them with interstate commerce. In consideration of the January 2, 2001, United States Supreme Court decision, Solid Waste Agency of Northern Cook County v. United States Army Corps of Engineers, we have determined Pond 1 and Wetland 5 to be isolated and non-jurisdictional, without a connection to inter-state commerce.
