The observed flow originated at the outfall pipe from Excluded Resource B and flowed through a gully down the dam fill. Upon hitting the toe of the dam, the flow spreads out as sheet flow prior to the headcut at the point of origins for Intermittent Stream 19. Soils within this area were evaluated and no evidence of redoximorphic features were observed suggesting groundwater interaction.

The pond receives surface flow via sheet flow and an upland swale and drains via a 12-inch drain pipe that only releases water when the pond is above full pool. The drainage flows down the constructed dam, where it turns to sheet flow upon hitting the toe of the dam. The sheet flow concentrates at the headcut forming the headwaters for IS 19. No hydric soils, evidence
