B. Typical year assessment(s): Resource & Land Consultants conducted a site visit on 8/6/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that normal rainfall conditions were present for the nearest weather station on the date of the site visit as published data was within 30% of the 30 year average.
