- **B.** Typical year assessment(s): The data forms provided by Resource Land Consultants indicate that they performed a wetland delineation of the project area on 8/11/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined the delineation was conducted during the wet season (WebWIMP H2O Balance) and that "normal" rainfall conditions were present for the nearest weather station on the date of the wetland delineation.
- **C.** Additional comments to support AJD: The pond was constructed entirely within uplands and there is no direct hydrologic surface connection between the pond and other jurisdictional waters in a typical year. The pond is 5.6 miles from the nearest TNW, the Lower Savannah River.
