C. SIGNIFICANT NEXUS DETERMINATION

5AS-2002-09752

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations will include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are no surface or subsurface hydrologic connections between the 3.99-acre non-jurisdictional isolated wetland and other jurisdictional waters. The wetland is not located within the 100-year floodplain. The wetland is located approximately 600 feet from the nearest jurisdictional water, and approximately 3,200 feet from the nearest named waterway, Canes Creek. The uplands surrounding the isolated wetland are approximately 8 to 12 inches higher in elevation than the surface elevation of the isolated wetland. The soils in the uplands surrounding the isolated wetland are mapped as Leefield Loamy Sand (LdA), and are not considered suitable for providing subsurface flow between the isolated wetland and other waters.
