### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland HH/HH2 is approximately 8.6 acres and 12.5 acres and located at 30.6599, -83.6586. The wetland is located approximately 1,680- feet from the nearest jurisdictional water, 1.5-miles from the nearest TNW (McMillen Bay), and 2,700-feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the

uplands that surround Wetland HH/HH2, are higher in elevation than the surface elevation of the wetland. The exception to this is the area to the south which the maps seem to indicate is a depression connection between the subject wetland and the nearest jurisdictional system. During the Corps site inspection it was noted that there was a ridge approximately 200' south of the subject wetland which is not shown on the LIDAR. This ridge acts to prohibit the flow of water from the subject wetland to the nearest jurisdictional system. The upland soils between the Wetland HH/HH2 and jurisdictional wetland is classified as Ochlockonee loamy sand. It is nonhydic and has a texture of sand loam, allowing for percolation of water. Based on the observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland to the wetland..
