2014 MONTHLY AGENCY MEETINGS**

The 2014 schedule for the Savannah District's, Regulatory Division (RD) monthly agency meetings is enclosed. Pre-application and Interagency Review Team (IRT) Meetings will be held in the Savannah District Office for project sites located in the Coastal Branch (RD-C) area of Georgia. Meetings will be held in the Piedmont Branch (RD-P) Morrow Field Office, for project sites located in the RD-P area. A map depicting the RD-C and RD-P areas of Georgia is enclosed. Please note that Inter-agency Quarterly Meetings are not open to the public.

Contact RD-C or RD-P at least one month in advance of the desired meeting date to schedule a pre-application meeting for a proposed project. A RD Project Manager (PM) or Regulatory Specialist (RS) will be assigned to the project, and will be responsible for scheduling a date and time for the meeting. The PM/RS will also provide instructions for submitting a pre-application information package (project description, maps, drawings, plans, etc.) to the participating federal and state resource agencies. The information package must be submitted at least two weeks prior to the date of the scheduled meeting. Failure to submit information to the resource agencies on time will result in meeting cancellation.

The prerequisites for scheduling an Interagency Review Team (IRT) meeting are outlined in the enclosed diagram titled "Draft Prospectus Process and Timeline." The PM/RS assigned to the mitigation bank will schedule the IRT meeting. For detailed information concerning the mitigation bank review and approval process, refer to the document titled "Savannah District, U.S. Army Corps of Engineers, Draft Guidelines to establish and Operate Mitigation Banks in Georgia," located at <http://www.sas.usace.army.mil/Missions/Regulatory.aspx>.


