

# Camp Croft FUDS Update Remedial Action



**BUILDING STRONG** 

### Project 03/05

- ▶ Remedial Action (RA) implemented in June 2020 (Public education 3Rs)
- Maintenance event tentatively planned for FY26
  - Inspection and maintenance (as needed) of warning signs
  - Reproduction and mailing of educational brochures
  - Coordinate distribution of educational brochures with Spartanburg County for building and land disturbance permits

### **Project 07**


- ► Public education 3Rs (sign installation (June 2020) and brochure reproduction (April 2021)
- ▶ Phase I RA contract period of performance ended 31 March 2025.
- ▶ Phase II RA contract was awarded on 30 September 2024. Mobilization to resume field work is tentatively scheduled for 5 June 2025 (AGC).



# Camp Croft FUDS Update Remedial Action (Project 07)



- Partial work stop order on 2 May 2023 due to project scope and site condition changes and inability to add additional acres under task order.
- Contractor completed the remaining field tasks under the partial work stop order and demobilized from the project in August 2023.
- Phase I (31 March 2020 2025)
  - ► Surface MEC clearance on 717 acres
  - ► AGC survey completed on 591 acres
  - ► AGC data fully processed on 521 acres
  - Intrusive investigations completed on 277 acres and 16 acres of analog investigation






# Camp Croft FUDS Update Remedial Action (Project 07)



- Phase II (31 Sept 2025 September 2029)
  - ▶ Complete remainder of Phase I (ie: ~71 acres of data processing and 315 acres TOI investigations)
  - Work divided up into 4 Areas
  - ► Anticipating ~350 acres Intrusive investigations to be completed
  - ► Interim RACR will be provided on work completed



#### **Project 07- Hurricane Helene:**

In late September 2024, Hurricane Helene impacted Project 07, resulting in downed trees throughout Croft State Park. In response, Weston performed both ground-based and aerial site reconnaissance surveys in October and November 2024.

#### Results divided into 4 main categories:

- No Impact Effort to complete work in these grids is unchanged. No newly fallen trees present.
- 2. **Minor Impact** Effort to complete work in these grids is relatively unchanged. 1 or 2 newly fallen, smaller trees may be present.
- 3. Moderate Impact Effort to complete work in these grids is changed. Approximately 3 to 7 newly fallen trees (~5 trees per grid; 20 trees per acre, on average) present.
- 4. Widespread Impact Effort to complete work in these grids is changed. 8 or more newly fallen trees (~12 trees per grid; 48 trees per acre, on average) present.

#### **Five-Year Reviews:**

- Five-year review (FYR) are required by CERCLA when hazardous substances remain on site above levels that permit unlimited use and restricted exposure.
- Purpose of the FYR is to evaluate the implementation of the remedy to determine whether it remains protective of human health and the environment.
- First FYR for Camp Croft FUDS Property
  - ➤ Site visit was conducted on 31 May 2023 and FYR Report was signed on 26 September 2023. Second FYR will be due September 2028.

#### **FYR Report Conclusion & Recommendations:**

- Perform annual maintenance and repair of warning signs.
- Review, update, and distribute brochures, annually, provide future press releases and public notices for educational material availability.
- Place the site-specific fact sheet on the project website, consider periodic open houses to promote awareness of MEC at the former Camp Croft.
- ► Contact property owners that expressed specific concerns in FYR interviews.
- Coordination with Spartanburg County to provide the current remedy status of each project and provide educational materials with building and land disturbance permits to ensure future protectiveness.
- Overall Conclusion: The remedy is currently protective of human health and the environment for Projects 03 & 05.



### RAB Membership



- New Croft State Park Ranger (replacement members RAB By-laws section IV.I)
- RAB Members shall serve a two-year term, at which time they
  may re-submit an application to serve another two-year term (RAB
  By-laws section A)
- RAB Community Chair shall be elected annually, shall be held for one year with re-election restricted to one additional term (RAB By-laws section V)
- All current RAB members have served more than a 2-year term
- Need to confirm willingness and interest to stay on RAB

#### Community Members

Community members provide information; seek independent technical advice when appropriate and feasible; communicate public conce RAB; and provide information and progress reports to the public Community Members may include, but are not limited to the foll

Landowners, local residents, (local government, business commi school districts, local environmental groups/activists, civic/publi organizations, religious community, local regulatory agencies, homeoness associations, medical community, economically disadvantaged, and African American, Native American, Hispanic, and other minorities) so as to comply with the Executive Order on Environmental Justice 12898.

- The Camp Croft RAB shall consist of no more than nine members.
- The RAB Members shall serve a two-year term, at which time they may re-submit an application to serve another two-year term.
- · Prospective RAB members will submit an application to the U.S. Army Corps of Engineers for approval.
- All Members of the RAB shall follow the Camp Croft RAB F. V. on attendance, and informal Robert's Rules of Order for cour

member has received prior approvar from the NAD.

If any RAB member is unable to fully participate, the member should submit a written resignation to a RAB chairperson. Resigning members are permitted to recommend or designate new members to replace them. Replacement members will also be sought from those individuals who were

#### The Election of the Community Chair

The Community Chair shall be elected annually by a majority vote of RAB Members by written ballot. For the initial election, names of individuals who have expressed an interest to serve as Chair will be placed on a ballot. A Chair will be selected by a majority vote of the RAB. For subsequent elections, a Nomination Committee of three Community Members may be appointed by the Community Chair to recommend a nominee for the Community Chair. Other members may be nominated from the floor. Write-in candidates and self-nomination are other avenues for election to the Community Chair position. Written ballots will be counted, and the results announced. The elected Chair position shall be held for one year with re-election restricted to one additional term. The Chair-elect will assume office at the next RAB meeting.



### RAB Membership



- Camp Croft RAB by-laws state the Army Facilitator must:
  - ▶ Invite the general public to the RAB meetings by inviting via postcard notification.
  - Maintain a mailing list of people interested in restoration activities at the former Camp Croft.
- Current list is not up to date and contains over 550 addresses, of which over 50 are returned as undeliverable
- Discuss if current list should be updated or by-laws amended to remove post card mailings
