C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The observations and findings for the features are detailed as follows:

The 4.7 acre borrow pit is located at Latitude 32.166213, Longitude -81.34621. The borrow pit is approximately 1,300 feet from the nearest jurisdictional water, and approximately 3.86 miles from the nearest TNW (Little Ogeechee River). On average the uplands immediately adjacent to the non-jurisdictional borrow pit are at least 2- 6 feet higher in elevation than the surface elevation of the non-jurisdictional borrow pit. There is no natural or man-made discrete and/or confined surface water connection between or among the 4.7 acre borrow pit and any other jurisdictional water. Further, there is no evidence of surface or subsurface water connections to or from this feature, nor is the feature located within the mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is no probability that floodwaters would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. Based on the site inspection and a review of available mapping and this feature's landscape position, it does not appear to be a component of any recognizable hydrologic system. Also, based on observed site conditions and soil permeability, it appears that any surface and/or subsurface flow would occur from the upland into the borrow pit. Lastly, this 4.7 acre upland dug borrow pit was constructed entirely in uplands, is non-naturalized, and is an active borrow pit associated with obtaining borrow material
