C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are no natural or man-made discrete and/or confined surface water connection between the subject features and any other jurisdictional waters. Further, there is no evidence of surface-water flow to or from these features, nor are they located within the mapped 100 year flood plain. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into these features. Consequently, based on the site inspection and review of available mapping, the isolated wetlands are not located immediately upslope of other jurisdictional waters. Historic land management activities and landscape position have severed hydrologic connectivity from the adjacent hydrologic system. The observation for the features are detailed as follows:

Wetlands W1(0.2-ac) and W2(0.79-ac) have no surface or subsurface hydrologic connections to any other jurisdictional waters. The observation for the features are detailed as follows:

Wetland 1: The depressional isolated wetland is 0.20 acre located at 31.859427, -81.336194. The wetland is 540 linear feet from the nearest jurisdictional water, approximately 1.3 miles from the nearest TNW (Jerico River, and over 2,000 linear feet from the 100 year flood plain). The uplands surrounding the wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. The attached LiDAR image and topographic map do not depict a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The upland soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham Sand or Albany Fine Sand, Pelham is poorly drained whereas Albany Fine sand is very poorly drained, both have sand textures. With the upland soils being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland 2: The depressional isolated wetland is 0.79 acre located at 31.857067, -81.338016. The wetland is 260 linear feet from the nearest jurisdictional water, and 1.1 miles from the nearest TNW (Jerico River, and over 1,500 linear feet from the 100 year flood plain). The uplands surrounding the wetland are approximately 1-2 foot higher in elevation than the average surface elevation within the wetland. During the site inspection no surface connection such as ditches or swales were found between this wetland and other jurisdictional waters. Further there is no evidence of surface-water flow to or from the feature. The attached LiDAR image and topographic map do not depict a depressional surface feature between the isolated wetland to the nearest jurisdictional water, where water might flow during a major rainfall event. The upland soils located between the isolated wetland and the nearest jurisdictional wetland are mapped as Pelham Sand, which is poorly drained. With the upland soil being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.
