C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 7 (3.10 acre): Lat: 31.470099 Long:-81.71708. There are no surface or subsurface hydrologic connections between the 3.10-acre non-jurisdictional isolated Wetland 7 and other jurisdictional waters. Wetland 7 is not located within the 100-year floodplain. Wetland 7 is more than 400 feet from the nearest jurisdictional water, and approximately 3,800

feet from the nearest TNW. The landscape surrounding Wetland 7 is approximately 3 feet higher in elevation than the surface elevation of Wetland 7. The soils surrounding Wetland 7 are mapped as Olustee sand and Plummer soils, less than 2% slopes. These soil types are considered hydric. Although these soil types are considered to be permeable enough to provide for subsurface flow, in this depressional setting, subsurface flow is expected to flow into the wetland and not out of the wetland towards a Traditionally Navigable Waterway (TNW). Wetland 7 was reviewed in the field on 18 March 2015. The perimeter of Wetland 7 was walked to investigate for the presence of ditches, swales or other type of hydrologic connection to jurisdictional wetlands. No hydrologic connection was observed. A distinct and obvious transition to upland vegetative species was observed along the entire perimeter of Wetland 7. Soils transition to a loamy sand lacking any evidence of hydric soils indicators outside the perimeter of Wetland 7. Wetland 7 is an isolated depression within an area managed for silviculture.

Wetland 8 (1.07 acres): Lat: 31.473394 Long:-81.718287. There are no surface or subsurface hydrologic connections between the 1.07 acre non-jurisdictional isolated Wetland 8 and other jurisdictional waters. Wetland 8 is not located within the 100-year floodplain. Wetland 8 is 315 feet from the nearest jurisdictional water, and approximately 3,950 feet from the nearest TNW. The landscape surrounding Wetland 8 are approximately 2 feet higher in elevation than the surface elevation of Wetland 8. The soils surrounding Wetland 8 are mapped as Olustee, however they resemble a Mascotte loamy sand, less than 2% slopes. This soil type is described as moderately slowly permeable and in this depressional setting, subsurface flow is expected to flow into the wetland and not out of the wetland towards a TNW. Wetland 8 was reviewed in the field on 18 March 2015. The perimeter of Wetland 8 was walked to investigate for the presence of ditches, swales or other type of hydrologic connection to jurisdictional wetlands. No hydrologic connection was observed. A distinct and obvious transition to upland vegetative species was observed along the entire perimeter of Wetland 8. Soils transition to a loamy sand lacking any evidence of hydric soils indicators outside the perimeter of Wetland 8. Wetland 8 is an isolated depression within an area managed for silviculture.
