C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland KA is 0.382 acres and located at 31.285289, -81.488725. The wetland is located approximately 1,438 feet from the nearest jurisdictional water, 3.3 miles from the nearest TNW (Wally's Leg), and 2,661 feet from the 100-Year Floodplain. During the site inspection,

no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland KA, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the Wetland KA and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland BX is 0.207 acres and located at 31.279606, -81.494152. The wetland is located approximately 4,163 feet from the nearest jurisdictional water and approximately 3.5 miles from the nearest TNW (Burnett Creek), and 2,493 feet from the 100-Year Floodplain. Although an upland dug stormwater pond is located adjacent to Wetland BX, this feature is not jurisdictional, so therefore allows Wetland BX to remain isolated. In addition the upland dug stormwater pond has no outlet and has no connection to Wetland BX. The elevation increases between Wetland BX and the upland dug stormwater pond, allowing for no connection between the two features. The upland soils between the isolated wetland BX and all surrounding jurisdictional wetlands have a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland CA/KC is 1.217 acres and located at 31.269804, -81.498563. The wetland is located approximately 1,203 feet from the nearest jurisdictional water and approximately 3.0 miles from the nearest TNW (Burnett Creek), and 3,106 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found to run downhill to any other wetland or jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland CA/KC, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

Wetland CB is 1.564 acres and located at 31.266743, -81.498931. The wetland is located approximately 995 feet from the nearest jurisdictional water and approximately 3.0 miles from the nearest TNW (Burnett Creek), and 2,669 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland CB, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. It should be noted that part of the wetland depicted on the topographic map, was previously verified as isolated and filled, however Wetland CB is a remnant isolated wetland from that fill.

Wetland CC is 0.037 acres and located at 31.266743, -81.498931. The wetland is located approximately 948 feet from the nearest jurisdictional water and approximately 3.0 miles from the nearest TNW (Burnett Creek), and 2,573 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland CC, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. It should be noted that part of the wetland depicted on the topographic map, was previously verified as isolated and filled, however Wetland CC is a remnant isolated wetland from that fill.

Wetland BC is 1.097 acres and located at 31.265807, -81.497968. The wetland is located approximately 600 feet from the nearest jurisdictional water and approximately 2.9 miles from the nearest TNW (Burnett Creek), and 2,338 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland BC, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. Wetland CD is 0.039 acres and located at 31.266136, -81.496537. The wetland is located approximately 593 feet from the nearest jurisdictional water and approximately 2.9 miles from the nearest TNW (Burnett Creek), and 2,288 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found between the wetland and other jurisdictional waters. As depicted in the attached LiDAR and topographic maps, the uplands that surround Wetland CD, are higher in elevation than the surface elevation of the wetland. In addition, these maps also show that there is no depressional surface feature between the isolated wetland and nearest jurisdictional wetland, prohibiting the flow of water after events like heavy rainfall. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. It should be noted that part of the wetland

depicted on the topographic map, was previously verified as isolated and filled, however Wetland CD is a remnant isolated wetland from that fill.

Wetland BD is 0.232 acres and located at 31.261792, -81.496261. The wetland is located approximately 798 feet from the nearest jurisdictional water and approximately 2.8 miles from the nearest TNW (Burnett Creek), and 1,790 feet from the 100-Year Floodplain. This wetland is depressional in nature and occurs completely within an upland ridge that is higher in elevation than any wetland in close proximity to it. As depicted on the LiDAR and topographic maps, the uplands that surround Wetland BD show that there are no depressional surface features that connect the isolated wetland to any jurisdictional wetland, which prohibits the flow of water after events like rainfall. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found to lead from Wetland BD to any other jurisdictional water. The upland soils between the isolated wetland and jurisdictional wetland has a texture of sand, allowing for percolation of water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland.

The 13.953-acre borrow pit located in the center of the property, is upland constructed and therefore is non-jurisdictional water. The borrow pit is located approximately 4,141 feet from the 100-Year Floodplain. During the site inspection, no surface connections, such as ditches, swales, and other connections, were found to lead from the borrow pit to any other jurisdictional water. There are no outlets from the borrow pit. The upland soils between the borrow pit and jurisdictional wetlands has a texture of sand, allowing for percolation of water. However, this soil type is not considered permeable enough to provide for subsurface flow between the subject wetland and other waters.
