C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

0.85 Acre Wetland Area:

The wetland area is part of a depression wetland that extends to the east onto another parcel where this wetland was previously verified as isolated and non-jurisdictional (See USACE Project No. SAS-2014-00325). There is no surface or subsurface hydrologic connection between the 0.85-acre non-jurisdictional isolated wetland and other jurisdictional waters. The wetland is not located within the 100-year floodplain. This wetland area is located over 27,000 feet from the nearest TNW (St. Augustine Creek). The uplands surrounding the isolated wetland are approximately one to two feet higher in elevation than the surface elevation of the isolated wetland, and there is no connection (pipe/culvery/swale) under existing roads that would allow for the chemical, physical, or biological connectivity of this wetland to waters of the U.S. Furthermore, there are no ditches, swales, topographic features, or other conveyences on the site that could act as a connection between this 0.85 acre wetland area and other jurisdictional waters. The vegetation surrounding the wetland consists of typical upland species for Chatham County. The isolated wetland is approximately 2000 linear feet north of Pipe Makers Canal which flows eastward and connects to the Savannah River. The landscape between the isolated wetland and Pipe Makers Canal is developed both commercially and residentially and has no surface aquatic features that could provide any connectivity. The underlying soil profiles between the isolated wetland and Pipe Makers Canal is comprised of Cape Fear, Ellabelle, Mascotte and Ocilla series. These series are comprised of clayey marine and fluvial sediments that are somewhat poorly drained to very poorly drained and have slow to moderate permeability. These soil profiles would be the most direct sub surface hydrological connection to the canal, however, with the route having been developed and covered with impermeable surface, this sub surface conneciton no longer exists. A field site visit confirmed there are no ditches, swales, creeks, rivers or other connectivity means for the isolated wetland to connect to another water of the U.S.
