B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:

Site is predominately planted loblolly pines. Review of USGS, NWI, USDA-NRCS resources did not indicate possible wetlands. Listed soils (Dothan, Fuquay) are well-drained, non-hydric soils. Two data points confirm uplands.
