This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Thirteen isolated pocket depressions are in the review area, however, they did not exhibit a connection to other wetlands/waters based on the site visit. LIDAR, topographical, and soil maps were also evaluated in the determination. The isolated wetlands are not located within the mapped 100-year floodplain and are approximately one mile or more from Spring Creek, the nearest Traditional Navigable Water (TNW), which is also the nearest jurisdictional water. During the inspection of the

site, no surface connection was found between the isolated wetlands and jurisdictional waters. The topographic map does not depict a depressional surface feature between the isolated wetlands and the nearest jurisdictional feature where water might flow during a major rainfall event. The upland soils located around the isolated wetlands are primarily mapped as Blanton loamy sand (BlB), which has a sandy texture and is considered permeable. Even though the upland soils are permeable, a shallow subsurface connection cannot be documented due to the topography and distance from the isolated wetlands to the nearest jurisdictional water. No large wetland systems or stream channels were observed on or within approximately one mile of the site. The thirteen identified features consist of isolated depressions and topographic low wooded areas with no connection to other wetlands/waters.
