Summarize overall biological, chemical and physical functions being performed: Wetland area collects water in a depression. There is subsurface flow after periods with rain rainfall levels. After poll levels recede slightly, most water is lost via evaporation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The upland excavated borrow pits are excavated in dry land for the purpose of obtaining fill material. It is our opinion that the borrow pits are upland excavated and were field verified on October 29, 2019. As discussed on Page 41217 of the preamble to 33 CFR Part 320 through 330, Regulatory Programs of the Corps of Engineers, Final Rule, "For clarification it should be noted that we generally do not consider the following waters to be "Waters of the United States." (E) Water filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel.
