If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

There is no natural or man-made discrete and/or confined surface water connection between or among the subject feature and any other

jurisdictional water. Further, there is no evidence of surface-water flow to or from these feature, nor are they located within the mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into this feature. Consequently, based on the site inspection and a review of available mapping, as these feature are not located immediately upslope of other jurisdictional waters, and based on their respective landscape position, it does not appear to be a component of any recognizable hydrologic system.
