- **B.** Typical year assessment(s): At the time of field verification, the site is wetter than normal, per Antecedent Precipitation Calculator. Therefore, regardless of the climatic conditions exceeding the 70% probability for the 30-day rolling average of recorded precipitation during the growing season for this location, no waters of the US are present within the review area.
- **C.** Additional comments to support AJD: Site visit conducted on 19 June 2020. Site consists of a portion of an existing driveway and extends into a farm field. The proposed tower pad area is located at the edge of the farm field and a wooded area. All areas are upland, no aquatic resources within the 0.45-acre review area.
