Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from several nearby weather stations to estimate a 30 year normal range for rainfall conditions, we have determined that normal rainfall conditions were present in the vicinity of the site on the date of the wetland delineation.](#)
