- B. Typical year assessment(s):** The data forms provided by Resource Land Consultants indicate that a they performed a wetland delineation of the project area on 8/29/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from nearby weather stations, we have determined the delineation was conducted during the dry season (WebWIMP H2O Balance) and that “Normal” rainfall conditions were present for the nearest weather stations on the date of the wetland delineation. With regards to the site visit on 8/13/2020, the Antecedent Precipitation Tool results, which used rainfall data from nearby weather stations, indicated that the site visit was conducted during the dry season (WebWIMP H2O Balance) and that “Normal” rainfall conditions were present for the nearest weather stations on the date of the wetland delineation.
- C. Additional comments to support AJD:** A number of the wetlands listed as excluded “non-adjacent” wetlands in Section II.D. did have ditches connecting the features to downstream waters. However, all of the ditches, with the exception of the ditch labeled as Intermittent Stream W on the attached “Wetland Exhibit”, observed on site appear to not be aquatic resources in that they did not exhibit a clear OWHM, nor did they exhibit the three criteria necessary to be classified as a wetland. These ditches appear to have been constructed through upland areas in order to provide positive drainage of low depressional areas to improve agricultural activities. The review area is located on a flat ridge that drains at off-site to the north, southeast and southwest and the drainage area for each of the wetlands in the project area is small. These non-adjacent wetlands appear to simply be poorly drained, depressional areas in a flat landscape that would never have been adjacent to any (a)(1)-(a)(3) waters as defined in the NWPR.
