C. Additional comments to support AJD: Based on a review of the information provided by the applicant, the Corps previously verified delineation and a review of aerial photos of the subject wetlands, it has been determined that there are no (a)(1)-(3) waters entering or exiting the above referenced wetland. Additionally, the wetland is not located in the flood plain of any waterway and is situated in a depressional area that is completely surrounded by uplands. Based on the landscape position of the wetland, it is very unlikely that floodwater would reach an elevation necessary for water to flow from any (a)(1)-(3) waters into the wetlands in a typical year. The wetland is not adjacent to any (a)(1)-(a)(3) waters as defined by the NWPR. The wetland does not abut any (a)(1)-(a)(3) waters, is not inundated by any (a)(1)-(a)(3) waters, is physically separated from all (a)(1)-(a)(3) waters and does not have a direct hydrologic surface connection to any (a)(1)-(a)(3) waters in a typical year.
