B. Typical year assessment(s): The wetland delineation was conducted in July 2020. Using the Atecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that normal conditions were present.

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

C. Additional comments to support AJD:

"Non-adjacent Wetland" as depicted on "Aquatic Resource Delineation Sketch" is surrounded by upland to the south, west, and north and a stormwater pond to the east. The stormwater pond that has a pipe is perched 1' above the wetland floor and normal precipitation events do not connect the pond and the strormwater pond. Elevated roads without culverts surround the property to the east, west, and north do not provide connectivity to an (a)(1)-(3) water. Furthermore, the stormwater ponds do not provide a direct hydrologic surface connection to an (a)(1)-(3) water during a typical year. The site was previously verified as all upland under SAS-1997-19870 in a letter dated December 17, 1997. Non-adjacent Wetland 1 is 0.25 miles from the nearest TNW, Grove River.
