**C. Additional comments to support AJD:** The 0.57 acre wetland is depressional with no inflow or outflow. There are no natural or manmade discrete and/or confined surface hydrology connections between this depressional wetland and any other jurisdictional waters. The consultant observed no surface connections. During times of heavy precipitation there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the wetland. The 0.57 acre wetland does not meet any of the adjacency criteria in the NWPR. The wetland does not abut an (a)(1) through (a)(3) water, is not inundated by flooding from an (a)(1) through (a)(3) water, and is physically separated from all (a)(1) through (a)(3) waters.
