Additional comments to support AJD: [Based on a review of the information provided by the applicant, a review of aerial photos of the subject wetlands, Corps site visit and all other available information, it has been determined that there are no \(a\)\(1\)-\(3\) waters entering or exiting the above referenced wetlands. Additionally, the wetlands are not located in the flood plain of any waterway and are situated in depressional areas that are completely surrounded by uplands. Based on the landscape position of the wetlands, it is very unlikely that floodwater would reach an elevation necessary for water to flow from any \(a\)\(1\)-\(3\) waters into the wetlands in a typical year. The wetlands are not adjacent to any \(a\)\(1\)-\(a\)\(3\) waters as defined by the NWPR. The wetlands do not abut any \(a\)\(1\)-\(a\)\(3\) waters, are not inundated by any \(a\)\(1\)-\(a\)\(3\) waters, are physically separated from all \(a\)\(1\)-\(a\)\(3\) waters and do not have a direct hydrologic surface connection to any \(a\)\(1\)-\(a\)\(3\) waters in a typical year.](#)
