B. Typical year assessment(s): The data forms provided by Sligh Environmental Consultants, Inc. indicate that the wetland delineation of the property was performed on 6/30/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from a nearby weather station, we have determined the delineation was conducted during the dry season (WebWIMP H2O Balance) and that “normal” rainfall conditions were present for the nearby weather station on the date of the wetland delineation.
