- **B.** Typical year assessment(s): The wetland jurisdictional status assessment was conducted on 10 August 2020. Using the Antecedent PrecipitationTool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that normal conditions (product of 12) were present during the time of the assessment.
- **C.** Additional comments to support AJD: Wetlands E, I, J, and K are all depressional landforms surrounded by uplands with no surface hydrologic connection to any other waters in a typical year.
