B. Typical year assessment(s): [The data forms provided by the agent indicate they performed a wetland delineation of the project area on 2/25/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from Savannah International Airport weather station, we have determined that the delineation was conducted during the wet season \(WebWIMP H2O Balance\) and that “normal” rainfall conditions were present for the nearest weather station on the date of the delineation.](#)
