- **B.** Typical year assessment(s): The data forms provided by Environmental Services, Inc, indicate that they reviewed the project area on October 29, 2020. Using the Antecedent Precipitation Tool Version 1.0 (APT), which used rainfall data from the Savannah International Airport weather station, we have determined that the review conducted on October 29, 2020 was done during the wet season (WebWIMP H2O Balance) and that "normal" conditions were present.
- **C.** Additional comments to support AJD: No areas within the site exhibited all three wetland parameters. Therefore, the 1.12-acre property is comprised entirely of uplands.
