Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined the delineation was conducted during the wet season \(WebWIMP H2O Balance\) and that normal rainfall conditions were present on the date of the site visit.](#)

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
