B. Typical year assessment(s): The wetland jurisdictional status assessment was conducted on 16 September 2019. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Brooklet 1 W weather station, we have determined that wetter than normal conditions were present during the time of the assessment

C. Additional comments to support AJD: Non-adjacent Wetland C is surrounded entirely by upland. There is no direct hydrologic surface connection between Wetland C and any other jurisdictional wetlands. This wetland is greater than 4 miles from the nearest TNW, Mill Creek.

Non-adjacent Wetland D is surrounded entirely by upland. There is no direct hydrologic surface connection between Wetland D and any other jurisdictional wetlands. This wetland is greater than 4 miles from the nearest TNW, Mill Creek.
