Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined the delineation was conducted during the wet season (WebWIMP H2O Balance) and that "Normal" rainfall conditions were present for the nearest weather station on the date of the wetland delineation.
