C. Additional comments to support AJD: Based on a review of the information provided by the applicant, a review of aerial photos of the subject wetlands and all other available information, it has been determined that there are no (a)(1)-(3) waters entering or exiting the above referenced wetlands. Additionally, the wetlands are not located in the flood plain of any waterway and are situated in depressional areas that are completely surrounded by uplands. Based on the landscape position of the wetlands, it is very unlikely that

floodwater would reach an elevation necessary for water to flow from any (a)(1)-(3) waters into the wetlands in a typical year.
