- B. Typical year assessment(s): The data forms provided by Resource Land Consultants indicate that they performed a wetland delineation of the project area on 8/21/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from area weather stations, we have determined the delineation was conducted during mild wetness (Drought Index (PDSI)) and that "normal" rainfall conditions were present for the nearest weather station on the date of the wetland delineation. With regards to the Corps site visit on 10/01/2020, the Antecedent Precipitation Tool results, which used rainfall data from area weather stations, indicated that the site visit was conducted during the incipient drought (Drought Index (PDSI)) and that "normal" rainfall conditions were present for the nearest weather stations on the date of the weither stations.
- **C.** Additional comments to support AJD: The wetland is a depressional feature surrounded by upland. There is no direct hydrologic surface connection between the wetland and other jurisdictional waters in a typical year. This wetland is approximately 320 feet from the nearest (a)(1) water, the Brunswick Altamaha Canal. A shallow ephemeral ditch is located on the east side of the wetland. However, this ditch does not contribute surface water to the nearest (a)(1) water in a typical year and is not a tributary by definition. The pond was constructed entirely within uplands and there is no direct hydrologic surface connection between the pond and other jurisdictional waters in a typical year.
