**C. Additional comments to support AJD:** Non-adjacent Wetland A is surrounded entirely by upland or other non-adjacent wetlands. There is no direct hydrologic surface connection between Wetland A and any other jurisdictional wetlands. This wetland is greater than 1.5 miles from the nearest TNW, the Ogeechee River.
