- B. Typical year assessment(s):** The data forms provided by Sligh Environmental Consultants, Inc, indicate that they initially reviewed the project area on September 13, 2019. Using the Antecedent Precipitation Tool Version 1.0 (APT), which used rainfall data from the Savannah International Airport weather station, we have determined that the site visit was conducted during the presence of “normal” conditions during an “incipient drought” (PDSI). Further, a site visit with the Corps was conducted on November 23, 2020, and the APT results indicate that “normal” conditions were present during an “incipient drought” (PDSI).
- C. Additional comments to support AJD:** Wetland 4 as depicted on the enclosed survey is a depressional wetland that is surrounded by uplands. A review of aerial imagery, USFWS NWI data, USGS Topographic Maps, and other data sources in conjunction with the site visit performed on November 23, 2020, does not indicate that these wetlands have any clear potential to meet the definition of an adjacent wetland under the NWPR.
