- **B.** Typical year assessment(s): The wetland delineation was conducted in December of 2020. Using the Atecedent PrecipitationTool Version 1.0, which used rainfall data from the 4 of the closest weather stations, we have determined that wetter than normal conditions were present for the nearest weather station during the assessment in 2020.
- **C.** Additional comments to support AJD: Non-adjacent Wetlands A & B are surrounded by development. There is no direct hydrologic surface connection between Wetlands 1-3 and any other jurisdictional waters. These wetlands are 1.3 miles from the nearest TNW, Hog Crawl Creek. Wetland B connects to the interior/ mall drainage stormwater system. The ditch appears to have ephemeral flow at best and appears to have been constructed within uplands or non-adjacent wetlands. Wetland A does not reach the ditch to the north but if it did it would drain into the the roadside ditch where it would not leave other than ground infiltration. There are no culverts under Scranton Connector.
