B. Typical year assessment(s): The data forms provided by Resource Land Consultants, indicate that a they performed a wetland delineation of the project area on 8/12/2020. Using the Atecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that normal rainfall conditions were present for the nearest weather station on the date of the wetland delineation.

C. Additional comments to support AJD: Wetland A is surrounded entirely by upland. There is no direct hydrologic surface connection between Wetland A, and any other jurisdictional wetlands. This wetland is greater than ±5.5 miles from the nearest TNW, Savannah River.

Wetland B is surrounded entirely by upland. There is no direct hydrologic surface connection between Wetland B, and any other jurisdictional wetlands. This wetland is greater than ±5.5 miles from the nearest TNW, Savannah River.

Wetland C is surrounded by upland to the north, south, and east, and existing road to the west. There is no direct hydrologic surface connection between Wetland C and any other jurisdictional wetlands. This wetland is greater than ±5.5 miles from the nearest TNW, Savannah River.

Wetland D extends off the subject site. Within the property, the wetland is surrounded by uplands to the north, west, and east. Off-site, the wetland is surrounded by uplands to the south, west, and east. There is no direct hydrologic surface connection between Wetland D and any other jurisdictional wetlands. This wetland is greater than ±5.5 miles from the nearest TNW, Savannah River.
