C. Additional comments to support AJD: US Drought Monitor map identifies no abnormal weather/drought events occurring at the time of this inspection. Based on a review of all data compiled for our AJD evaluation, we have determined that the subject (b)(1) resource is excluded under NWPR based on it not meeting one of the four adjacency criteria paragraph (c)(1) of the rule. The depressional wetland is isolated by surrounding uplands and is only adjacent to a non-jurisdictional ditch.
