**B.** Typical year assessment(s): The wetland delineation was conducted in October of 2020. Delineated resources jurisdictional status was assessed on November 3, 2020. Using the Atecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that normal conditions were present for the nearest weather station during the delineation in
