B. Typical year assessment(s): [The data forms provided by Resource Land Consultants indicate that they performed a wetland delineation of the project area on October 17, 2018. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined the delineation was conducted during the wet season \(WebWIMP H2O](#)

Balance) and that “normal” rainfall conditions were present for the nearest weather station on the date of the wetland delineation.

- C. Additional comments to support AJD:** The project area was previously determined to be upland by Corps letter dated July 30, 2001. The existing depressional wetland is bordered to the south, east and west by existing roads and to the north by a commercial development. A culvert is located on the northwest portion of the site but is elevated and connects to the stormwater management system within the adjoining development. Therefore, this wetland does not contain a surface water connection during a typical year. These wetlands are approximately 0.63 miles from the nearest TNW (Little Ogeechee River).
