B. Typical year assessment(s): The data forms provided by Resource and Land Consultants, indicate that they reviewed the project area on December 8, 2020. Further, a site visit with the Corps was conducted on March 16, 2021, and the APT results for that date indicate that the site visit was conducted under “wetter than normal” conditions.

C. Additional comments to support AJD: All of the non-adjacent wetlands and Pond A listed on this AJD are depressional features that are surrounded by uplands. A review of aerial imagery, USFWS NWI data, USGS Topographic Maps, LiDAR and other data sources in conjunction with the site visit performed on March 16, 2021, does not indicate that these wetlands have any clear potential to meet the definition of an adjacent wetland under the NWPR.
