**B. Typical year assessment(s):** [The wetland data forms for the site indicate that a wetland delineation of the project area was performed on 10/07/2019. Based on the Antecedent Precipitation Tool Version 1.0, which used rainfall data from the Savannah International Airport weather station, we have determined that drier than normal conditions were present for the nearest weather station on the date of the wetland delineation.](#)

Wetland A is a depressional landform surrounded on all sides by upland. There is no direct hydrologic connection between this wetland and an (a)(1)-(3) water. Wetland A is 2.5 miles from the nearest TNW, Savannah River.
