B. Typical year assessment(s): The data forms provided by Resource Land Consultants indicate that they performed a wetland delineation of the project area on 09/01/2020. Using the Antecedent Precipitation Tool Version 1.0, which used rainfall data from area weather stations, we have determined the delineation was conducted during the wet season (WebWIMP H20 Balance) and that "normal" rainfall conditions were present for the nearest weather station (Savannah International Airport) on the date of the wetland delineation.

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

C. Additional comments to support AJD: The wetland is a depressional feature surrounded by developed and undeveloped uplands. There is no direct hydrologic surface connection between the wetland and other jurisdictional waters in a typical year. This wetland is approximately 0.7 miles from the nearest (a)(1) water, Pipemakers Canal.
