- C. Additional comments to support AJD:** Wetland A is surrounded on all four sides by developed upland. To the north is US Highway 80, to the east and west are commercial and residential development and to the south is Sharon Park Landfill. A ditch runs between the southern project boundary and the landfill, which has been mounded to approximately 30'. This upland cut ditch conveys stormwater from the landfill and surrounding development to a series of drainage ditches. At the time of this assessment approximately 2" of water was observed standing in the ditch with no signs of flow or evidence to indicate that it serves any other function than to transport water during periods of rainfall.
