**B. Typical year assessment(s):** The data forms provided by Resource and Land Consultants, indicate that they reviewed the project area on February 5, 2021, in addition the Corps conducted a site visit on March 16, 2021 and the APT results for that date indicate that the site visit was conducted during the “wet season” (WebWIMP H2O Balance), under “wetter than normal” conditions.

**C. Additional comments to support AJD:** Wetland A, D and E listed on this AJD are depressional features that is surrounded by uplands. A review of aerial imagery, USFWS NWI data, USGS Topographic Maps, LiDAR and other data sources in conjunction with a site visit do not indicate that Wetland A, D, or E have any clear potential to meet the definition of an adjacent wetland under the NWPR. Wetland B, C and F on this AJD directly abut an (a)(1)-(a)(3) water and meets the definition of an adjacent wetland under the NWPR. Additionally Pond A in not adjacent under (b)(8) as it was excavated entirely in upland.
