Typical year assessment(s):** The data forms provided by Sligh Environmental Consultants, Inc., indicate that they reviewed the project area on April 20, 2021, and the APT results for that date indicate that the site visit was conducted with a “wet season” (WebWIMP H2O Balance) under “normal” conditions.
- C. Additional comments to support AJD:** Wetlands 1,2 and 3 listed on this AJD are depressional features that are surrounded by uplands. A review of aerial imagery, USFWS NWI data, USGS Topographic Maps, and other data sources does not indicate that the wetlands have any clear potential to meet the definition of an adjacent wetland under the NWPR.
