- **B.** Typical year assessment(s): The project was reviewed by Corps staff on July, 19, 2021, and the APT results for that time frame indicate that the site visit was conducted during the "dry season" (WebWIMP H2O Balance) under "wetter than normal" conditions.
- **C.** Additional comments to support AJD: Pond A listed on this AJD is a depressional features that is surrounded by uplands with no connections to any other eligible or ineligiable aquatic resource. A review of aerial imagery, USFWS NWI data, USGS Topographic Maps, and other data sources does not indicate that pond A has a clear potential to meet the definition of an adjacent wetland under the NWPR.
