Explain: **One ephemeral swale was identified within the project area. The ephemeral swale channelizes in the western portion of the project area from a concrete box culvert under I-675 and bisects the site. The channel has a discontinuous bed and bank that is mostly filled with leaf litter and woody debris and is interrupted by spoil piles located throughout the depression. The swale does not have an ordinary high-water mark. The swale terminates at a double corrugated metal pipe (CMP) culvert system that conveys storm flow under Grant Road and the parking lot**

located east of the project area. The swale ranges from 2 to 4 feet in width and 1-2 feet in depth. The feature has no in-channel structures, depositional bars, or benches. The channel bed consists of sand, gravel, and cobble. Fibrous roots and rooted plants were observed within the channel. Baseflow was not present at the time of observation on June 3, 2021. No wetlands were delineated within the project area. One (1) data point (UP1) was sampled at the lowest elevation within the depression to describe the area most likely to exhibit wetland characteristics. Sample plot did not meet any of the three wetland criteria..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
