Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): Subject feature is approximately 0.07-acre in size. Based on historic aerial imagery available on Google Earth, the existing concrete manufacturing facility, and the subject attendant basin, appear to have been established between 1993 and 1999. The original design configuration of the basin incorporated a low earthen berm along the western edge of the site to serve as a conveyance to direct stormwater, process water and accompanying pollutants for collection within the basin. The "Storm Water Pollution Prevention Plan for Ready Mix USA, LLC, Auburn Operation, 269 Parks Mill Road, Auburn, Georgia 30011", dated December 21, 2007, references the subject feature as a "recycling pond", the purpose and operation within the facility for which is described as follows: "Process water is collected and treated in a series of settling ponds. The water from the settling ponds is then pumped into a recycling pond and is reused in the plant. The settling ponds are cleaned on a regular basis and the waste material is also recycled. Stormwater runoff from this site in the process area is collected and used in the batch plant. Stormwater not in the process area is discharged from the site at outfalls." Consequently, this feature has been determined to be a component of the overall facility treatment system constructed to meet requirements of Clean Water Act, " to either convey or retain, concentrate, settle, reduce, or remove pollutants, either actively or passively, from wastewater prior to discharge (or eliminating any such discharge)", and is therefore excluded from jurisdiction.
