C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There is no evidence of surface-water flow to these features from jurisdictional features, nor are any of the isolated wetlands listed below located within the mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into these features. Consequently, based on the site inspection on October 21, 2021 and review of available mapping, the isolated wetlands are not located immediately upslope of other jurisdictional waters. Historic activities along this roadway, consist of roadway construction, residential development, agricultural, silvicultural, and community based activities. The observation for the features are detailed as follows:

Wetland I (1.89 acre), Completely surrounded by upland, nearest jurisdictional water is 1,500 linear feet to the southeast and the closest TNW is approximately 2.5 miles north (Woodyard Creek). Soils within Wetland I, are Surrency mucky fine sand, soils within the upland are Leefield loamy sand. Leefield loamy sand is somewhat poorly drained, moderately slowly to slowly permeable soils on the uplands of the Southern Coastal Plain Major Land Resource Area. With the upland soils being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Wetland I is not located within the mapped 100-year floodplain. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. The uplands surrounding the wetland are two to three feet higher in elevation, than the surface of the isolated wetland. Even though there are culverts within Wetland I, they traverse laterally (east to west, and not north to south), they do not attach or create any connectivity with a jurisdictional water. Therefore, Wetland I is isolated, and would be considered non-jurisdictional.

Wetland W (2.33 acre), Completely surrounded by upland, nearest jurisdictional water is 3,389 linear feet northwest, and closest TNW (Woodyard Creek) is approximately 0.54 miles north. Soils within Wetland W, are Pelham fine sand, and soils within upland surrounding are Mascotte fine sand. The Pelham fine sand consists of very deep, poorly drained, moderately permeable soils that formed in unconsolidated Coastal Plain sediments. The upland soils surrounding Wetland W consist of Mascotte fine sand consist of very deep, and poorly and very poorly drained, moderately slowly permeable soils. With the upland soils being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. Wetland W is not located within the mapped 100-year floodplain. There is a single culvert that is in close proximity to that goes under the roadway from south to north, however, there is a significant break in upland from wetland to the culvert. There is approximately two to three feet elevation difference surrounding the wetland on all sides. Therefore, Wetland W is isolated, and would be considered non-jurisdictional.

Wetland AD (2.47 acre), Completely surrounded by upland, nearest jurisdictional water is 721 feet to the southeast, and it is 0.87 miles north from the nearest TNW (Woodyard Creek). The soils within Wetland AD are Surrency mucky sand, with the upland soils surrounding the wetland consisting of Mascotte fine sand and Leefield loamy sand. Leefield loamy sand is somewhat poorly drained, moderately slowly to slowly permeable soils on the uplands of the Southern Coastal Plan Major Land Resource. The upland soils surrounding Wetland AD consist of Mascotte fine sand consist of very deep, and poorly and very poorly drained, moderately slowly permeable soils. With the upland soils being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. Wetland AD is not mapped within 100-year floodplain. The area surrounding Wetland AD are consistently two to three feet higher in elevation. Therefore, Wetland AD is isolated, and would be considered non-jurisdictional.

Wetland AG (0.76 acre), Completely surrounded by uplands, nearest jurisdictional water is 178 linear feet north, and closest TNW (Woodyard Creek) is 1.9 miles north. The soils within Wetland AG are Pelham loamy fine sand. The Pelham fine sand consists of very deep, poorly drained, moderately permeable soils that formed in unconsolidated Coastal Plain sediments. The soils surrounding Wetland AG consist of Mascotte fine sand consist of very deep, and poorly and very poorly drained, moderately slowly permeable soils. With the upland soils being poorly drained, a shallow subsurface connection cannot be documented due to the distance from the isolated wetland to the nearest jurisdictional water. Based on observed site conditions and soil permeability, it appears that any subsurface flow would occur from the upland into the wetland. Wetland AG is not mapped within 100-year floodplain. The area surrounding Wetland AG consists of areas ranging from one to three feet higher. Therefore, Wetland AG is isolated, and would be considered non-jurisdictional.
